Dear Sir or Madam,

Thank you for your email dated 21 November 2025 inviting National Highways (NH) to comment on additional documents submitted as part of the updated Schedule of Main Modifications.

National Highways has been appointed by the Secretary of State for Transport as strategic highway company under the provisions of the Infrastructure Act 2015 and is the highway authority, traffic authority and street authority for the strategic road network (SRN). The SRN is a critical national asset and as such National Highways works to ensure that it operates and is managed in the public interest, both in respect of current activities and needs as well as in providing effective stewardship of its long-term operation and integrity.

We will therefore be concerned with proposals or policies that have the potential to impact the safe and efficient operation of the SRN in the vicinity of the plan area, in this case the M3 & A34 which pass north-south through the area and a small section of the M27 which passes through the southern part of the district.

We have reviewed the proposed main modifications and offer no comments.



Dear Sir/Madam,

Thank for you for consulting with Southern Water on the Proposed Main Modifications to the Local Plan, we have no recommendations to make directly in relation to the Modifications. However, further to our recent engagement, we advise the following.

As part of our consultation response to the Regulation 18 Local Plan and Regulation 19 Local Plan, Southern Water assessed the capacity of the public sewer networks that would serve each site allocation. This was done using predicted flows from the number of dwellings proposed for each site.

In agreement with Winchester LPA, we have not undertaken an assessment of any variance in dwelling numbers for sites as part of this Main Modifications proposal.

The reason being is that dwelling numbers have gone down due to some construction having already taken place, therefore those properties have connected to the sewer network, and as such remain part of the network capacity output for the Local Plan.

We understand that there will be a Water Cycle Study in 2026 to support the next Local Plan, we would welcome early engagement on the study to understand parameters and to ensure that Southern Water provides valuable input.

We hope the above is helpful and we look forward to being kept informed of progress. We would also like to thank you for the high level of engagement we have received throughout the consultation process for the Local Plan.
